Resolved, that pursuant to their request, Lockport Main Street, Inc., subject to a thirty day cancellation notice, is hereby designated as the Canal Street Manager for 2010, and is given permission to utilize Canal Street from the intersection of Church Street to Ontario Street for the period of June 1, 2010 though September 1, 2010 for the purpose of providing retail/commercial activity (including recruitment and selection of a limited number of vendors, set uniform hours for vending and monitor the offerings of City of Lockport licensed vendors) and the scheduling and use of the entertainment in the Canal Street Performance Pavilion, and be it further

Resolved, that the Police Chief be and the same is authorized and directed to provide regular police patrols, the Superintendent of Highway Parks and Refuse is authorized and directed to provide daily street cleaning and refuse removal services, the Director Of Engineering is authorized and directed to make arrangements for electricity and street lighting, and the Director of Utilities is authorized and directed to provide water service to the area, and be it further

Resolved, that subject to the review and approval of the Director of Community Development, Lockport Main Street, Inc. is given permission to coordinate related site improvements, streetscaping and signage on the buildings fronting on Canal Street that are owned by the City of Lockport, and be it further

Resolved, that Lockport Main Street, Inc. is hereby given access and use of first floor space, at no cost, of 79 Canal Street or other buildings for the purpose overnight storage of vending equipment and related supplies
