Whereas, the City wishes to create a source of funds to demolish dilapidated housing it acquires via its In-Rem procedure, now therefore be it

Resolved, that the City Treasurer is hereby authorized and directed to establish a General Fund Capital Reserve Fund for the purpose of depositing monies derived from the sale of real property via the City's In-Rem Procedure and transfer funds as follows:
