WHEREAS, several local businesses desire to display A-frame signs in front of their establishments in accordance with the sign ordinance, and

WHEREAS, the law precludes the placement of any object within the City's right of way without Common Council authorization, and

WHEREAS, for many local businesses along Main Street the City's right of way extends up to the front of their building with little or no room to properly display said signs, and

WHEREAS, on or about December 20, 2009 the Department of Building Inspection notified several local businesses along Main Street to remove their signs from said right of way, and

WHEREAS, the Common Council desires to temporarily grant for a period of 90 days to display A-frame signs as approved by the Department of Building Inspection in accordance with the City's sign ordinance. NOW THEREFORE BE IT

RESOLVED, that the Chief Building Inspector be and is hereby authorized to issue permits in accordance with the City of Lockport's Sign ordinance to businesses located adjacent to Main Street for a period of not more than 90 days.
