The Town of Lockport, New York, Zoning Code and Map as adopted and amended from time to time, is hereby amended as follows:

The following described parcel of land, which is currently in the Local Business Use District (B-1 District), is hereby rezoned so that it will hereafter form a part of the General Business Use District (B-2 District), and the regulations applying to the B-2 District shall apply to said parcel:

ALL THAT TRACT OR PARCEL OF LAND, designated on the Tax Map of the Town of Lockport as Tax Map Number 138.00-2-13.2.

PLEASE TAKE NOTICE that a Public Hearing will be held by the Town Board of the Town of Lockport on the 4th day of December, 2013, at 7:30 P.M. at the Town Hall, 6560 Dysinger Road, Lockport, New York, on the adoption of a proposed Local Law entitled, "A Local Law Amending Chapter 80 of the Code of the Town of Lockport", an abstract of which is as follows:

§80-11(A) is repealed and the following is adopted in its place:

§80-11(A)

The fee for each spayed or neutered dog shall be \$7.00 plus an additional fee (surcharge) required by Agricultural and Markets Law §110(3) in the amount of \$1.00.

§80-11(B) is repealed and the following is adopted in its place:

§80-11(B)

The fee for each unspayed or non-neutered dog shall be \$15.00 plus an additional fee (surcharge) of \$3.00 as required by Agricultural and Markets Law §110(3).

The following section is added:

§80-11(G) There shall be an additional fee of \$5.00 (a late fee) for any dog license obtained more than 30 days after it was due to be obtained.
