

## AGREEMENT

**THIS AGREEMENT** made this 15<sup>th</sup> day of April, 2015, by and between **All Season Party and Tent Rental**, 5885 Transit Road, East Amherst, New York 14051, hereinafter referred to as ("All Season Party") and the **TOWN OF LOCKPORT, 6560 Dysinger Road, Lockport, NY 14094**, hereinafter referred to as "Town".

**NOW, THEREFORE**, it is duly agreed by the two parties herein as follows:

1. That All Season Party shall provide a 20x40' white stake tent with solid sidewalls, (100) black folding chairs, (8) 4 x 50 Red Carpet Runners, (10) Banquet tables, 8 x 16 stage and black stage skirt for the Town at the Lockport Town Hall from 06/11/2015 to 06/15/2015.

2. The Town shall pay All Season Party \$2,138.76 for the aforesaid rental from June 11th, 2015 to June 15th, 2015 and this fee includes the set up and take down of the tent and all rented items as listed above.

3. All Season Party shall provide the Town with a Certificate of Liability Insurance in the amount of at least \$1,000,000.00. The Town shall be named an additional insured.

4. All Season Party shall indemnify and hold harmless the Town from any liability arising from the provision of services as set forth in this agreement.
