

**NOTICE OF PUBLIC HEARING
TOWN OF LOCKPORT**

PLEASE TAKE NOTICE that a Public Hearing will be held by the Town Board of the Town of Lockport on December 7, 2016, at 7:30 p.m., at the Town Hall, 6560 Dysinger Road, Lockport, New York, on the adoption of a proposed Local Law entitled, "A Local Adding Storm Sewers Chapter to the Code of the Town of Lockport", an abstract of which is as follows:

Section 160-1 provides for the purpose and intent for storm sewer regulations. Section 160-2 sets forth the definitions found in said Local Law. Section 160-3 establishes the general provisions of the Law. Section 160-4 sets forth discharge prohibitions relating to storm sewers. Section 160-5 provides for prohibition against activities contaminating stormwater. Section 160-6 sets forth the requirements to prevent, control and reduce stormwater pollutants by the use of the best management practices. Section 160-7 establishes the compliance for industrial or construction activity discharges. Section 160-8 sets forth the suspension of access to MS-4. Section 160-9 provides for the access and monitoring of discharges. Section 160-10 sets forth the requirements for notification of spills. Section 160-11 provides for the enforcement of said Law. Sections 160-12 and 160-13 provide for appeal of notice of violation and corrective measures after the appeal. Section 160-14 sets forth injunctive relief if failure to comply with any standards of this Law. Section 160-15 sets forth alternative remedies in lieu of civil penalties. Section 160-16 establishes violations deemed a public nuisance. Section 160-17 establishes that remedies of this Law are not exclusive and Section 160-18 sets forth the severability of said Law.
