

**NOTICE OF PUBLIC HEARING
TOWN OF LOCKPORT**

PLEASE TAKE NOTICE that a Public Hearing will be held by the Town Board of the Town of Lockport on December 7, 2016, at 7:30 p.m., at the Town Hall, 6560 Dysinger Road, Lockport, New York, on the adoption of a proposed Local Law entitled, "A Local Amending the Zoning Chapter of the Code of the Town of Lockport in relation to Stormwater Management", an abstract of which is as follows:

1. Section 200-4 adds the term and definition for "Stormwater Pollution Prevention Plan" (SWPPP).
2. Section 200-126 adds Subsection O relating to approval of the SWPPP pursuant to Section 200-212(B).
3. Section 200-127 adds Subsection E relating to performance and design criteria and standards of the SWPPP.
4. Article XXX entitled, "Stormwater Management" is added to the Zoning Chapter as follows:

Section 200-209 provides the authority findings and purposes of said Article. Section 200-210 sets forth the definitions found in said Article. Section 200-211 establishes the general provisions of the Law. Section 200-212 sets forth the procedures for SWPPPs. Section 200-213 establishes SWPPP requirements, contents, permits, contractor certification and that a copy of the SWPPP shall be retained at the site during construction. Section 200-214 sets forth the performance and design criteria for stormwater management and erosion and sediment control. Section 200-215 establishes the maintenance, inspection and repair of stormwater facilities. Section 200-216 provides for the administration and enforcement of the Law. Section 200-217 sets forth severability of the Law.

5. "Sample Stormwater Control Facility Maintenance Agreement" is added as Appendix A to Chapter 200 Zoning Attachment 5.

At such Public Hearing, all persons interested, who wish to be heard, will be heard.
