NOTICE OF PUBLIC HEARING**

PLEASE TAKE NOTICE that the Town Board of the Town of Lockport will hold separate public hearings on the matters referred to herein at the Town Hall, 6560 Dysinger Road, Lockport, New York, on the 6th day of November, 2019, at 7:30 p.m. Said public hearings shall be as follows:

1. A Public Hearing on the Preliminary Budget for the fiscal year beginning January 1, 2020 as required by Town Law section 108 for the purpose of considering the preliminary budget, and receiving comments from the public relative thereto. Said Budget is on file with the Town Clerk of the Town of Lockport where it may be inspected by any interested person during normal office hours.
