

**NOTICE OF PUBLIC HEARING
TOWN OF LOCKPORT – SEWER DISTRICT NO. 3 - PHASE 2**

PLEASE TAKE NOTICE that the Town Board of the Town of Lockport, Niagara County, New York, by resolution dated February 3, 2016, ordered that a public hearing be held at the Town Hall, 6560 Dysinger Road, Lockport, New York 14094 on March 2, 2016 at 7:30 p.m. to consider whether it is in the public interest to approve the hereinafter described project:

The Town Board is considering whether to authorize certain improvements to the Town's Sewer District No. 3 - Phase 2, consisting of the following:

(a) rehabilitation or replacement of pump stations located throughout the Sewer District (as more particularly identified in the Map, Plan and Report), including without limitation: (i) rehabilitation or replacement of pumps, replacement of impellers and/or motors, replacement of vacuum pumps and/or priming lock loop, and piping modifications; (ii) electrical improvements, including installation of sonic starts, variable frequency drives, new control panels and new controllers, fail switches, gauges and alarms; (iii) generator replacements and improvements; (iv) structural improvements, including removal and replacement of wet well ladders and the installation of new wet well hatches and insulated fiberglass covers; (v) site work improvements, including painting and installation of pig launchers and/or pigging of force mains; and (vi) any ancillary and related work or improvements in connection with the foregoing; and

(b) the cleaning, inspection, assessment, rehabilitation and improvement of portions of the Sewer District's sanitary sewer lines including, without limitation, slip lining the existing pipe and manholes using Cured-in-Place (CIP) piping, cementious grouting, chemical root treatment, and any ancillary or related work required in connection therewith (collectively, the "Project").

The estimated maximum cost of the Project is \$7,560,000.

All persons interested in the aforementioned Project and the subject matter thereof are invited to attend.
