The proposed project (Base Bid) is the preparation and installation of approximately 1,400 linear feet of concrete sidewalk with associated drainage, topsoil, establishing turf, striping and signage on Shimer Drive and installation of approximately 2,800 linear feet of concrete sidewalk with associated topsoil, establishing turf, striping and signage on Locust Street. The proposed project (alternate # 1) is preparation for concrete sidewalk on Locust Street including excavation, placement of Subbase and associated drainage. All work is within the Town of Lockport.
