A regularly scheduled work session of the Lockport Town Board was conducted at 1:00 p.m. on Monday, January 7, 2013, at the Town Hall, 6560 Dysinger Road, Lockport, New York.

Safe Routes to Schools Grant - Supervisor Smith stated that the Town has received notification that the Town will receive approximately \$500,000.00 of a \$570,000.00 collaborative grant application sent in by the Town of Lockport Economic Development office and the Lockport Board of Education. The grant funding will secure monies to install sidewalks in two locations within the Town of Lockport; on East High Street as well as on Locust Street Extension. More information will be forthcoming.
