

March 24, 2015

A special meeting of the Lockport Town Board was conducted at 1:00 p.m. on Tuesday, March 24, 2015 at the Town Hall, for the purpose of introducing Local Laws amending the Town of Lockport Code and calling for Public Hearings on said proposed Local Laws. All Town Board members were given written notice prior to said meeting and the following members attended.

Supervisor Smith thanked those present and explained that the purpose of the meeting was to introduce five proposed Local Laws which were previously introduced at the March 18, 2015 work session, but as one all-inclusive Local Law. Mr. Norris added that there were no substantial changes from the previously introduced Local Law but it was necessary to re-introduce the material for each separate Chapter having proposed amendments. Additionally, he stated it was necessary to rescind the motion calling for a Public Hearing that was adopted at the March 18, 2015 meeting.

**MOTION (2015-86):** to rescind (MOTION:2015-83) calling for a Public Hearing on a proposed Local Law entitled "Amendments to Agricultural and Design Review, Sewers, Subdivision of Lands, Water, and Zoning Chapters of the Code of the Town of Lockport" was made by Council member Keough and seconded by Council member Siejak. The motion was CARRIED: AYES-3, NAYS-0. Voting AYE: Siejak, Keough and Smith.

#### **INTRODUCTION OF PROPOSED LOCAL LAWS:**

Local Law #1 – A Local Law entitled "Amending the Architectural and Design Review Chapter of the Code of the Town of Lockport" was introduced by Council member Siejak.

**MOTION (2015-87):** to conduct a Public Hearing on a proposed Local Law entitled, "Amending the Architectural and Design Review Chapter of the Code of the Town of Lockport" for 7:30 p.m. on Wednesday, April 8, 2015, was made by Council member Keough and seconded by Council member Smith. The motion was CARRIED: AYES-3, NAYS-0. Voting AYE: Siejak, Keough and Smith.

Local Law #2 - A Local Law entitled "Amending the Sewers Chapter of the Code of the Town of Lockport" was introduced by Council member Keough.

**MOTION (2015-88):** to conduct a Public Hearing on a proposed Local Law entitled, "Amending the Sewers Chapter of the Code of the Town of Lockport" for 7:30 p.m. on Wednesday, April 8, 2015, was made by Council member Siejak and seconded by Supervisor Smith. The motion was CARRIED: AYES-3, NAYS-0. Voting AYE: Siejak, Keough and Smith.

Local Law #3 - A Local Law entitled "Amending the Subdivision of Land Chapter of the Code of the Town of Lockport" was introduced by Supervisor Smith.

**MOTION (2015-89):** to conduct a Public Hearing on a proposed Local Law entitled, "Amending the Subdivision of Land Chapter of the Code of the Town of Lockport" for 7:30 p.m. on Wednesday, April 8, 2015, was made by Council member Keough and seconded by Council member Siejak. The motion was CARRIED: AYES-3, NAYS-0. Voting AYE: Siejak, Keough and Smith.

Local Law #4 – A Local Law entitled "Amending the Water Chapter of the Code of the Town of Lockport" was introduced by Council member Siejak.

**MOTION (2015-90):** to conduct a Public Hearing on a proposed Local Law entitled, "Amending the Water Chapter of the Code of the Town of Lockport" for 7:30 p.m. on Wednesday, April 8, 2015, was made by Council member Keough and seconded by Supervisor Smith. The motion was CARRIED: AYES-3, NAYS-0. Voting AYE: Siejak, Keough and Smith.

Local Law #5 - A Local Law entitled "Amending the Zoning Chapter of the Code of the Town of Lockport" was introduced by Council member Keough.

**MOTION (2015-91):** to conduct a Public Hearing on a proposed Local Law entitled, "Amending the Zoning Chapter of the Code of the Town of Lockport" for 7:30 p.m. on Wednesday, April 8, 2015, was made by Supervisor Smith and seconded by Council member Siejak. The motion was CARRIED: AYES-3, NAYS-0. Voting AYE: Siejak, Keough and Smith.

Councilman Siejak requested that a copy of the proposed Local Laws, with all of the strikeout changes listed from that of the existing law, be made available to the public upon demand.

**MOTION (2015-92):** to adjourn was made by Council member Keough and seconded by Council member Siejak. The motion was CARRIED: AYES-3, NAYS-0. Voting AYE: Siejak, Keough and Smith.
