

RESOLUTION AUTHORIZING PUBLIC IMPROVEMENT PERMIT FOR LOCKPORT MEMORIAL HOSPITAL

WHEREAS, Catholic Health Systems has presented a site plan before the Town of Lockport Planning Board for the development of the Lockport Memorial Hospital, and

WHEREAS, the Town of Lockport Planning Board granted approval of the site plan on July 20, 2021, and

WHEREAS, the applicant wishes to proceed with the construction of public improvements within the Shimer Drive right of way, and

WHEREAS, the project requires roadway, waterline, and drainage improvements to be installed and offered to the Town of Lockport for dedication at a future date, and

WHEREAS, in accordance with Chapter 137 of the Town code, the developer is required to file a Public Improvement Permit application and has done so,

NOW THEREFORE BE IT RESOLVED, that the Town Board of the Town of Lockport approves the Public Improvement Permit for the installation of approximately 680 LF of roadway and round about and 412 LF of waterline and related appurtenances with the following conditions:

- 1. An Insurance Certificate, in accordance with Chapter 137-4B must be provided to the Building Inspector by the Contractor completing the work on behalf of Catholic Health Systems prior to commencing work along with an agreement signed by the General Contractor.
- 2. Four (4) signed and sealed copies of the design plans must be provided to the Building Inspector by the Contractor prior to commencing work.

RESOLUTION AUTHORIZING TOWN SUPERVISOR TO SIGN AGREEMENT WITH CONTRACTORS FOR LOCKPORT MEMORIAL HOSPITAL PIP

RESOLVED, that the Town Board of the Town of Lockport authorizes the Town Supervisor to sign the Contractor agreement with the contractors completing work for the Lockport Memorial Hospital Public Improvement Permit

RESOLUTION AWARD OF CONTRACT ROBINSON ROAD TELEVISING AND FLUSHING SANITARY SEWER ASSESSMENT CONTRACT NO. 22-3

WHEREAS, the Town of Lockport had authorized Wendel, the Town's Engineers to complete the contract documents for Town of Lockport Robinson Road Televising and Flushing Sanitary Sewer Assessment contract, and

WHEREAS, bids on the above referenced project were opened on March 15, 2022 in accordance with the Notice to Bidders previously authorized, and

WHEREAS, there was a math error on the extension of a unit price for the Base Bid for Pipe-Eye Sewer Services and Pipe Eye Sewer Services has provided a letter acknowledging the error and has agreed to complete the work under the base bid for the corrected project cost, and

NOW THEREFORE BE IT RESOLVED, that the Lockport Town Board authorizes award of the Base Bid, Alternate No.1 and Alternate No. 2 for Contract No. 22-3 to Pipe-Eye Sewer Services, Inc., 75 Holley Avenue, Bradford, PA 16701-1810 in the amount of \$57,822.59 contingent upon the Town Attorney's review of the Contractor's Bonds and Insurances.
